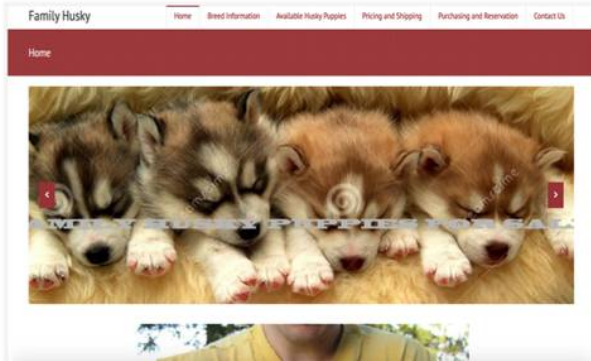



I contacted the breeder for information about a Siberian Husky I saw on their website (<http://huskypupsforsale.com>) that they supposedly had available and I asked for pictures of the dog and he was asking a reasonable price (\$200 for the dog and \$115 for shipping to DFW airport). Paypal account was not working so I sent it through money order. He claimed to be "God fearing" and "trustworthy" and "embarrassed" when I asked for his drivers license. After I paid him, his father "got more sick" and claimed he was going to be out of touch for the weekend and said he dropped the dog off with the shippers and they would be in contact with me to get the arrangements for shipping the dog. The 'shippers' emailed me asking to "rent an air-conditioned crate" for the Husky puppy I 'bought' from the breeder. They gave me a Paypal account, but required specific instructions in order for me to receive the

refund which didn't work so we used money order. I spoke to a "worker" over the phone and he assured me that he would complete the refund and a written agreement "for my father". After paying him he asked for \$500! I demanded the dog to be returned for a refund. He threatened not to said that I would lose the dog at the airport after 5 days they would set the dog free. When I got the dog after 5 days I demanded a refund of \$500 for an air conditioned dog crate. I was told to get a refund of \$500 and them and that he needed to go pick up the dog. He claimed that his father died and he was out of state and would not pick up the dog and he never would pick up his phone or have us a fake phone number. A few weeks later he apparently "picked up the dog from the shippers" and I was to get my refund... IF I paid another \$220 for "accommodations and feeding". After still going back and forth between them, I offered to just refund me \$530 (\$750 minus the \$220 I owe) and they still are saying
