Much like a Social Security Number, an Employer Identification Number (EIN) is a federal nine-digit number that identifies a business entity. The Internal Revenue Service (IRS) issues EINs and requires their use on all tax filings during the entire life of a business. The IRS generally requires the following types of businesses to obtain an EIN:

All corporations

All Limited Liability Companies (LLCs) with more than one member

Any business that hires employees, including sole proprietorships and single-member LLCs

Many nonprofit organizations, as well as trusts and certain co-ops, must also have an EIN. If a business establishes a trust for estate or emergency bankruptcy protection, it is usually required to apply for an EIN. A business that is a partnership, a trust, or a business that is a sole proprietorship, but is not a corporation, must also have an EIN. Open business checking accounts establish accounts with certain vendors. Sometimes you'll see the Employer Identification Number referred to as a Tax Identification Number (TIN) or Federal Employer Identification Number (FEIN). As a general rule, it is good for all businesses with the exception of sole proprietorships without employees, to have an EIN. We can obtain an Employer Identification Number (EIN) from the IRS on your business's behalf. The process is fast & easy.
